1. SPONSOR: Disney Online, 1200 Grand Central Avenue, Glendale, CA 91201 ("Sponsor").

2. ADMINISTRATOR: Ventura Associates International LLC, 60 East 42nd Street, New York, NY 10165 ("Administrator"), an independent judging organization whose decisions are final and binding with respect to this sweepstakes ("Sweepstakes").

3. ENTRY: You may enter this Sweepstakes via the internet during the period beginning at 12:01 P.M., July 10, 2014 and ending at 11:59 A.M., August 22, 2014 ("Entry Period"). For purposes of these Official Rules ("Rules"), all times and days are Pacific Time. You may enter by visiting <u>http://www.disney.com/setsailsweeps</u> ("Website) and completing the information requested ("Entry"). Normal Internet access and usage charges imposed by your on-line service will apply. Sponsor's computer is the official time-keeping device for the Sweepstakes.

4. LIMITATIONS: All Entries must be received by August 22, 2014. Entries are limited to one (1) Entry per person/email address for each day during the Entry Period, regardless of method of Entry or whether one person has more than one email address or more than one person uses the same email address. In event of a dispute regarding the identity of the person submitting an Entry, the Entry will be deemed to be submitted by the person in whose name the email address is registered. Entries by any method other than set forth above in Section 3 are void. Any use of automated or programmed methods of effecting Entry is prohibited. Open only to persons, who are, as of Entry, not minors as defined by their state of primary residence ("Minors"), and who are legal residents of, and physically located within, the 50 United States or D.C. (collectively, "Territory"), and are not employees of Sponsor, Disney Destinations, LLC or Administrator; their respective parent, subsidiary or affiliated companies; or the advertising, promotional or fulfillment agencies of any of them

(individually and collectively, "Entities"); nor members of their households or immediate families (defined as parents, children, siblings, step-parents, step-children, step-siblings and their spouses). Neither the Entities, nor any directors, shareholders, of their officers. employees, agents or representatives (individually and collectively, "Releasees") are responsible for Entries from persons residing, or physically located, outside the Territory; Entries that are altered, delayed, deleted, destroyed, forged, fraudulent, improperly accessed, inaccurate, incomplete, interrupted, irregular in any way, late, lost, misrouted, multiple, non-delivered, stolen, tampered with, unauthorized, unintelligible or otherwise not in compliance with these Rules; or for lost, interrupted or unavailable network, server, internet service provider, Website or other connections; telephone availability or accessibility; miscommunications; failed computer, satellite, telephone or cable transmissions, lines or technical failure; failed phone, computer hardware or software, failures, technical errors or difficulties; telephone transmissions: technical failures: unauthorized human intervention; traffic congestion; garbled or jumbled transmissions; undeliverable emails resulting from any form of active or passive email filtering; insufficient space in entrant's email account to receive email; or other errors of any kind, whether due to electronic, human, mechanical, printing, production or technical errors or other causes; even if caused by the negligence of any of the Releasees. Each of such potential Entries will be disgualified and any attempt by a person to use multiple email accounts to register more Entries than allowed by these Rules may result in disgualification at Administrator's sole discretion. Void where prohibited and subject to all applicable federal, state, local and municipal laws and regulations.

5. PRIZE: ONE (1) GRAND PRIZE: A seven (7) night *Disney Cruise Line* Vacation for winner and three (3) guests (individually, "Guest," collectively, "Group") leaving from Port Canaveral, FL ("Port") and taken aboard the *Disney Magic* ship ("Ship") to take place with a sail date between October 26, 2014 to May 10, 2015 (date subject to change at the sole discretion of Sponsor) ("Trip") consisting of the following elements for the Group: **[1]** one (1) stateroom (quad occupancy) aboard Ship ; **[2]** all onboard meals (with the exception of *Palo* Fine Dining); **[3]** Pre-paid Gratuities, Government Taxes and Fees (as defined on the *Disney Cruise Line* website); **[4]** if winner's residence is located more than two hundred (200) miles from the Port, round-trip coach air transportation on a Sponsor-selected carrier between a Sponsor-selected major metropolitan airport near winner's residence ("Airport of Origin") and major airport closest to the ship's homeport, but if winner's residence is located two hundred (200)

miles or less from the Port, round-trip ground transportation will not be provided and there is no compensation for mileage driven or reimbursement for fuel or a rented vehicle, however Port parking for one (1) vehicle for the duration of the cruise will be provided, and [5] airport/Port transfers if air transportation is provided. Approximate retail value ("ARV") of Grand Prize: \$7,374.48, which will vary depending upon point of departure and destination and seasonal fluctuation of cruise rates and airfares. At the sole discretion of the Sponsor, disgualification, forfeiture and the selection of an alternate winner (if time permits) may result from any of the following: [1] potential winner's failure to respond to email notification within two (2) business days after transmission; [2] the return of an email notification as undeliverable after three (3) attempts; [3] the return of any other notification as undeliverable: [4] potential winner's failure to provide Sponsor with satisfactory proof of age, identity and residency; [5] potential winner's failure to provide Administrator with satisfactory proof that he/she is the authorized account holder of the email address associated with the winning Entry; [6] potential winner's failure to provide any required additional information upon Administrator's request; [7] potential winner's failure to execute and return an Affidavit of Eligibility/Liability/Publicity Release within five (5) business days after its mailing; [8] potential winner's failure to be available to make the Trip by May 10, 2015 (subject to change at the sole discretion of Sponsor); [9] potential winner's failure to validly claim the prize by October 31, 2014, and [10] any other non-compliance with Rules. and/or alter said Fulfillment Film in perpetuity, in its entirety or in part, for any commercial and promotional purposes worldwide without any consultation or additional permission, or compensation, credit or attribution; [22] Sponsor has the right to conduct a background check ("Check") of any and all records of the winner including without limitation, civil and criminal court records and police reports, which he/she, to the extent necessary under law, shall authorize; [23] Sponsor has the right to conduct a Check of any and all records of the Guests including without limitation, civil and criminal court records and police reports, which he/she, to the extent necessary under law, shall authorize; [24] Sponsor may take all steps necessary to corroborate any information provided to Sponsor by the winner and Guests, and he/she will be obligated to provide necessary contacts and information for the Check, and [25] if any felony or misdemeanor conviction is found, or if there is anything that conflicts with Sponsor's image, Sponsor has the right, in its sole discretion, to disgualify the winner or the Guests from participating in the Trip or portions of the Trip and to pay the winner a cash substitute for the Trip or those portions that are removed.
